Enjoy the Delights of Summer on Leon County's Greenways

Imagine having miles and miles of pristine canopied trails to walk, run, bike, horseback ride, play sports, or just have a picnic, right in your own backyard. You don't have to imagine, it's already true. There are several beautiful



greenways in Leon County, including the Miccosukee Canopy Road Greenway, located from Fleischman Road to Crump Road. You'll find 500 acres of green space, 15 miles of trails, and picnic tables and benches throughout the entire greenway. Trailheads can be found at Edenfield Road, Thornton Road, and Crump Road. There is a visitor parking area at the Edenfield and Thornton Roads intersection. Be sure to check for a new trailhead being opened at Fleischman Road.

Also, the J.R. Alford Greenway at 2500 S. Pedrick Rd. was recently named as a Great Florida Birding Trail site. It has 870 acres of green space and approximately nine miles of trails. For more information, please contact Parks and Recreation at 488-0221 or visit www.leoncountyfl.gov.

Information on Dangerous and Aggressive Dogs on Website



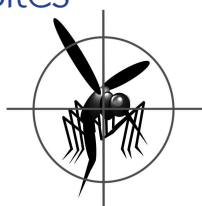
Leon County residents who would like to know if an aggressive animal is living in their neighborhood can now find out by visiting the Leon County Animal Control Website. The Division of Animal Control has posted the list of dogs that have been classified as dangerous or aggressive at www.leoncountyfl.gov/animal.

Every year, Leon County Animal Control receives and investigates complaints of animals that have threatened or harmed people or other animals. Many of these investigations result in the animals being classified as dangerous or aggressive under Leon County Code. Ordinance requires their

owners to follow certain restrictions, including keeping the animal in a locked, secure enclosure, and require the animal to be muzzled and walked on a leash. "These restrictions are in place to prevent any future actions from the animal that might threaten or harm the public", said Animal Control Director Richard Ziegler. If the classified animal is in violation of these restrictions, the public is encouraged to contact Leon County Animal Control at 487-3172 or the Leon County Sheriff's Office at 922-3300.

Protect Yourself from Mosquito Bites

With the return of the rainy season, the mosquitoes are back as well. Leon County Mosquito Control wants to remind you to protect yourself from bites and the potential diseases that mosquitoes can carry. Avoid being outdoors during the dawn and dusk hours, wear protective clothing and mosquito repellent, and make sure to remove any containers of standing water around your home where mosquitoes can breed.
