# Electronic, Household Hazardous Waste Collection Announced



The Leon County Solid Waste Management Division announces next monthly Household Hazardous Waste & Electronics Collection, which will take place on Saturday, Feb. 6, from 9 a.m. to 1 p.m. at the Public Works Operations

Center, 2280 Miccosukee Road.

When discarded, many household products can pollute and pose a health risk, so the Solid Waste Management Division holds these free events for Leon County residents. Businesses and other agencies must call (850) 606-1816 to make an appointment to drop off their items. Some fees will apply.

Citizens may bring up to 50 lbs. of hazardous waste, in addition to their electronics. Propane tanks must weigh less than 40 lbs., and there is a limit of one tire per participant. Medical sharps, medicines and radioactive waste cannot be accepted.

The Leon County Hazardous Waste Center, located at 7550 Apalachee Pkwy., is open Monday through Saturday, from 8 a.m. to 5 p.m.

# **H1N1 Vaccinations**

The Leon County Health Department is offering the 2009 H1N1 influenza (swine flu) shot and nasal spray to anyone who would like one.

Clinics are on a walk-in basis - no appointment necessary. The vaccine is free of charge. If residents are bringing children under 10 years of age, for the second dose, please bring the record for the first dose (if they have it) or be sure that the date it was given is known. The second dose should be given 28 days or more after the first.

## Leon Cares' service through partnering

County employees and local volunteers will address unmet housing rehabilitation needs in the Fairbanks Ferry community on Monday, Feb 15. Leon Cares encompasses nine separate properties, and volunteer duties include painting homes, removing downed trees and branches, and cleaning the inside of damaged or neglected mobile homes or houses.

Partnering with Leon County's Housing division, as well as Solid Waste Management, VolunteerLEON will administer, coordinate, and fund the project via a HandsOn Network grant. Volunteer youth leaders will monitor and assist at a youth station, directing children in making keepsakes for the homes of assisted families. Experienced volunteer leaders will direct 30-person work teams in many projects. Food and water will be provided for all on-site volunteers.

All volunteers are eligible for Disney's Give a Day, Get a Day campaign, which rewards one day of volunteer service with free admission to a Disney theme park.
