Recycle Christmas Trees, Styrofoam and More

The holidays bring extra trash into everyone's home, and Christmas trees, Styrofoam, and cardboard fill garbage carts quickly.

Leon County recycles Christmas trees into yard mulch, available for free to County residents. To recycle a tree, remove all ornaments, lights and tinsel and place the tree on the curb on a regular yard trash pick-up day. Residents can also bring trees to any of Leon County's four Rural Waste Service Centers. Bulky, white Styrofoam is not collected curbside, but it too can be recycled. Be sure to bring Styrofoam to the Solid Waste Management Facility, 7550 Apalachee Parkway.

Sports Council Opens 2nd Grant Cycle



The Tallahassee Sports Council, a division of Leon County's Tourism Development, also known as Visit Tallahassee, is currently accepting grant applications for the second cycle of sporting events with visitor impact that will take place spring, summer and/or early fall (prior to Oct. 1) of 2011. The Special Event Grant Program is designated to promote Tallahassee-Leon County as a preferred visitor destination.

To be considered for funding, the event must attract overnight visitors to the Tallahassee-Leon County area with a direct impact on transient lodging, including hotels, motels and campgrounds. Additional funding considerations include preference for events scheduled during traditionally low occupancy periods, number of out-of-town visitors, event scope and duration.

The first cycle of granted events for the current fiscal year included more than 60 sporting events with an anticipated 17,500 room nights and 34,000 visitors, which is expected to generate an estimated \$16 million in economic impact.

The application deadline for the second grant cycle is 5 p.m., Friday, Feb. 18, 2011, for events happening between March 4 and Sept. 30, 2011.
